1.1 AIIMS, Kalyani

All India Institute of Medical Sciences was established by an Act of Parliament as an autonomous institution of national importance Under the Pradhan Mantri Swasthya Suraksha Yojana [PMSSY] similar to AIIMS New Delhi and its objectives and functions were defined. By virtue of this Act, the Institute awards its own medical degrees, diplomas and other academic distinctions. The degrees and diplomas awarded by the Institute under the All India Institute of Medical Sciences Act are recognized medical qualifications for the purpose of the Indian Medical Council Act and notwithstanding anything contained in the Medical Council Act, are deemed to be included in the first schedule of that Act, entitling the holders to the same privileges as those attached to the equivalent awards from other universities of India. The institute started its journey on 4th September, 2019 with its first batch of MBBS students. Subsequently the seats have been increased to 125 for the year 2020. The admission process is being conducted through the common National Eligibility cum Entrance Test (Undergraduate) (or NEET (UG)) by the National Testing Agency (NTA). The Institute (AIIMS, Kalyani) is a residential University in which the faculty members, staff and the students live on campus. There are hostels for undergraduate and postgraduate students inside the campus.

AIMS & OBJECTIVES

2.1 Mission

Main mission is to establish a centre of excellence in medical education, training, health care and research imbued with scientific culture, compassion for the sick and commitment to serve the underserved.

2.2 AIMS

Correcting regional imbalances in the availability of affordable and reliable tertiary healthcare services and also to augment facilities for quality medical education creating a critical mass of doctors and conduct research in the country relevant to the area.

2.3 OBJECTIVES

- a. To develop a pattern of teaching in undergraduate and postgraduate medical education in all its branches so as to demonstrate high standard of medical education to all medical colleges and other allied institutions in India.
- b. To bring together in one place educational facilities of the highest order for the training of the personnel in all important branches of the health activity.
- c. To attain self-sufficiency in postgraduate in medical education.

The Course of studies leading to the award of degree of Bachelor of Medicine and Bachelor of Surgery (M.B.B.S.) of the All India Institute of Medical Sciences shall last for a minimum of five and a half academic years including one year's compulsory internship.

AIIMS, Kalyani:

The **125 (One Hundred and Twenty-Five)** seats for Indian nationals are available for admission to MBBS course. Out of these, **18 (eighteen)** seats are reserved for the Scheduled Castes, **9 (nine)** seats are reserved for the Scheduled Tribes, **33 (thirty three)** seats are reserved for Other Backward Classes (non-creamy layer), **12 (twelve)** seats are reserved for economically weaker section (EWS) and **53 (fifty three)** seats for General Category for Indian Nationals. A 5% reservation (six seats) for Person with Benchmark Disability (PWBD) as per provision of Rights of Persons with Disabilities Act, 2016 shall be provided on horizontal basis, amongst the seats available subject to evaluation by the Medical Board of the Institute.

CRITERIA FOR OTHER BACKWARD CLASSES (NON-CREAMY LAYER) [OBC]:

(Common to other AIIMs)

Reservation for OBC (Non-Creamy Layer) shall be according to the rules of the Government of India. Applicants are required to ensure that he/she does not belong to the persons/sections (Creamy Layer) mentioned in Column 3 of the Schedule to the Government of India, Department of Personnel & Training O.M. No. 36012/22/93-Estt. (SCT) dated 08/09/93 which is modified vide OM No.36033/3/2004 Estt. (Res.) dated 09/03/2004 or the latest notification of the Government of India (i.e. Central list).

CRITERIA FOR SCHEDULED CASTE/ SCHEDULED TRIBE (SC /ST):

(Common to other AIIMs)

Reservation for SC/ST candidates will be according to the rules of Government of India. Applicants will be required to produce the necessary certificate in the format provided. During counseling the certificate as prescribed in M.H.A., O.M., No. 42/21/49-N.G.S. dated the 28.1.1952, as revised in Dept. of Per-& A.R. letter No. 36012/6/76-Est. (S.CT), dated the 29.10.1977, to be produced by candidate belonging to a Scheduled Caste or a Scheduled Tribe in support of his/her claim.

CRITERIA FOR PERSONS WITH BENCHMARK DISABILITY (PWBD):

(Common other AIIMs)

In accordance with the provisions of the Rights of Persons with Disabilities Act, 2016, 5% seats of the annual sanctioned intake capacity shall be filled up by candidates with benchmark disabilities, based on the merit list of Entrance Examination 2020. For this purpose, the Specified Disability contained in the Schedule to the Rights of Persons with Disabilities Act, 2016. The candidate must possess a valid document certifying his/her physical disability. The disability certificate should be certified by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/institutions. All PWBD candidates shall be evaluated by a Medical Board of the Institute to determine eligibility.

CRITERIA FOR ECONOMICALLY WEAKER SECTION (EWS):

(Common to other AIIMs)

Reservation for EWS shall be according to the rules of the Government of India. Certificate to be produced during seat allocation should NOT be older than ONE Year on date of First end of Seat allocation.

5.1 SUPREME COURT RULES REGARDING ANTI RAGGING

As per direction of the Hon'ble Supreme Court of India, the Government has banned ragging completely in any form inside and outside the campus and all the AIIMS authorities are determined not to allow any form of ragging. Whosoever directly or indirectly commits, participates in, abets or instigates ragging within or outside any of the AIIMS shall have a FIR lodged against him/her and he/she will be suspended or rusticated from the institution and shall also be liable to be fined which may extend to Rs. 10,000/-. In case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he/she has indulged in ragging, admission can be refused or he/she shall be expelled from the educational institution. The punishment may also include, suspension from attending the classes, withholding/ withdrawing fellowship/ scholarship and other financial benefits or withholding the result.

5.2 ANTI RAGGING REGISTRATION

Selected candidates shall register himself/herself in the website www.antiragging.in / www.amanmovement.org and take a print out and submit the self-attested printout to Academic Section with 7 days.

6.1 GENERAL

AIIMS Kalyani have a MBBS course divided into three professional divisions First, Second and Third Professional MBBS are of one, one and half and two years duration respectively. The overarching goal is to cover the basics of all aspects of Medical Sciences. Admitted candidates must attend the Orientation/ foundation course Programme and join classes on the stipulated date.

Foundation course is to help the incoming fresh class of MBBS students get oriented to the curricular programme, the study environment and introduce them to some of the essential aspects of medicine that fall outside the purview of the core medical science disciplines, including language and communication skills, ethics and professionalism and leadership and computer skills.

Candidates selected for admission to the MBBS course at the AIIMS Kalyani after verification of their eligibility and offered admission should bring the following original certificates/ testimonials/documents at the time of admission:

- I. Certificate of having passed the 10+2 or equivalent Examinations, showing the subject offered by him/her in the Examination
- II. Certificate from the Board from which he/she passed the High School/Higher Secondary Examination, showing his/her date of birth.
- III. Certificate/Mark sheet from the Board from which he/she passed the 10+2 or equivalent Examination showing that he/she has secured 50% or more marks (40% in case of SC/ST/OBC) in aggregate in English, Physics, Chemistry and Biology. PwD candidates will get relaxation of 5% from the stipulated eligibility marks assigned for the respective category.
- IV. Migration Certificate from the University/Board last attended by him/her.
- V. Applicable only to candidate belonging to Scheduled Caste/Tribe/OBC/OPH/EWS Category:
 - a. SC/ST Certificate issued by the competent authority. Community should be clearly mentioned in the certificate.
 - b. OBC Certificate issued by the competent authority. The sub-caste should tally with the central list of OBC. OBC candidates should not belong to Creamy layer. OBC certificate must be in the prescribed format.
 - c. Certificate from prescribed authority showing that he/she belongs to Persons with Benchmark Disability Category.
 - d. Economically Weaker Section (EWS) Certificate issued by the competent authority.

The selected candidates will have to undergo a Medical Examination constituted by a Medical board setup by the Institute, consisting of faculty members of the Institute. If, in the assessment of the medical board, a candidate is found medically unfit to be admitted in the course, then he/she will be rejected and not admitted and the decision of the Board shall be final. The admission of the candidates, who fail to join the Course by the date stipulated in the letter of intimation, shall automatically be cancelled and such seats shall then be offered to the candidates on the waiting list in order of merit in the same category.

6.2 FEES & OTHER PAYMENTS

The dues are to be paid in the form of a Demand Draft in favor of “Executive Director, AIIMS Kalyani” payable at Kalyani drawn in any national bank immediately, after you have been declared medically fit in the Medical Board of the Institute as per details given below:

APPENDIX 6: SPECIFIED DISABILITY CLAUSE

A SCHEDULE is annexed regarding, "SPECIFIED DISABILITY" clause (zc) of section 2, that states as under,

1. Physical disability

A. Locomotor disability (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including—

- (a) "leprosy cured person" means a person who has been cured of leprosy but is suffering from—
 - (i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
 - (ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
 - (iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall be construed accordingly;
- (b) "cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
- (c) "dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less;
- (d) "muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterized by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;
- (e) "acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

B. Visual impairment—

- (a) "blindness" means a condition where a person has any of the following conditions, after best correction—
 - (i) total absence of sight; or
 - (ii) visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or 92
 - (iii) limitation of the field of vision subtending an angle of less than 10 degree.
- (b) "low-vision" means a condition where a person has any of the following conditions, namely:—
 - (i) visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
 - (ii) limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.

C. Hearing impairment -

- (a) "deaf" means persons having 70 DB hearing loss in speech frequencies in both ears;
- (b) "hard of hearing" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;

D. "Speech and language disability" means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.

2. Intellectual disability, a condition characterized by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behavior which covers a range of every day, social and practical skills, including—

- (a) "specific learning disabilities" means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;
- (b) "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviors.

3. Mental behavior,— "mental illness" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behavior, capacity to recognize reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterized by sub normality of intelligence.

4. Disability caused due to—

- (a) chronic neurological conditions, such as—
 - (i) "multiple sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
 - (ii) "Parkinson's disease" means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.
- (b) Blood disorder—
 - (i) "hemophilia" means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterized by loss or impairment of the normal clotting ability of blood so that a minor wound may result in fatal bleeding;
 - (ii) "thalassemia" means a group of inherited disorders characterized by reduced or absent amounts of hemoglobin.
 - (iii) "sickle cell disease" means a hemolytic disorder characterized by chronic anemia, painful events, and various complications due to associated tissue and organ damage; "hemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of hemoglobin.

5. Multiple Disabilities (more than one of the above specified disabilities) including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.

6. Any other category as may be notified by the Central Government.

Note: Any amendment to the Schedule to the RPWD Act, 2016, shall consequently stand amended in the above schedule.
