As per GFR 150 (I) to (v), it is necessary to make vendor registration for smooth functioning of indenting/ purchasing of materials on time which will help to achieve the ultimate goal of this Institution. The objectives of this vendor registration will be to

- 1. To recognize and enlist suitable vendors commensurate with their capabilities and performances, who are competent to supply required material and provide services in time bound manner.
- 2. To find out the vendors who are competent to supply goods and services to AIIMS Kalyani, but not registered in GeM and to motivate them to register their firms in GeM.
- 3. To ensure consistency, fair play and transparency in selection of vendors (when any particular item is not available in GeM), who are quality conscious and maintain strict specifications requirement for the end product
- 4. To provide all vendors equitable opportunity.

5. To provide an opportunity to vendors, who have been supplying products/Services to various Govt. Institute/organizations for more than three years, but not yet registered in GeM.

- 6. To ensure that majority of vendors registered for supplying items to AIIMS Kalyani are subsequently registered in GeM
- 7. And, also if any category of product is not available in GeM, to motivate the vendors to upload the on board the products as and when the items are listed on GeM.

- 1. The said registration only qualifies a particular vendor for consideration for issue of tender papers in case of limited tenders for relevant category only for which vendor is registered/empaneled. However, this will not give any claim to the party for award of work/purchase order.
- 2. AIIMS, Kalyani reserves the rights to accept, consider or reject any or all applications without assigning any reasons thereof. The decision of AIIMS, KALYANI, in respect of registration of parties for various categories of work / item shall be final & binding on all concerned registered firms / vendors in the panel of AIIMS, KALYANI.
- 3. The applicant should make sure before applying for a particular type of Category, that the firm has the required eligibility criteria & experience for that category of work / item.
- 4. One Single application form can be used for registering for multiple item categories. Relevant documents for all categories sought for registration should be provided.
- 5. The firm will be considered for registration / empanelment for an initial period of one year and their registration will be considered for renewal as per AIIMS KALYANI procedure, for two year or so, at a time subject to satisfactory performance of the firm since the initial registration period.
- 6. The firm should have an office in Kalyani/Kolkata and with state-of-art infrastructure and manpower / creative personnel / department (enclose organizational structure and photograph).
- 7. The registration process will consist of a multiphase evaluation with the possibility of Vendor's presentation, Factory/Site visit for inspection, verification of documents/ information, assessment of turnover, past performance, infrastructure etc. After completion of document review and other assessment as applicable, the case shall be taken up for Approval of competent authority and issue of registration letters will be obtained/ issued.
- 8. After getting all the required information & documents from the applicant, the registration number will be issued to the supplier with the following details:
 - (a) Registration No.
 - (b) Category code along with description
- 9. Successful registration by AIIMS KALYANI is no guarantee of any future award of Order for purchase / service / work or inclusion on a particular tender list.
- 10. Vendors once registered, shall have to promptly reply to all the enquiries, execute orders as per the order terms of AIIMS, KALYANI and keep the Institute informed of new products/developments / innovate ideas that shall help reduce the cost and improve quality, reliability etc.
- 11. Two-part tendering is done if technical screening/clear technical specification are not available. In such cases vendors will be asked to submit both techno commercial and price bids separately. Price bids of technically accepted bids only will be opened.
- 12. Registered vendors must be willing to supply urgent and emergency drugs and consumables in short notice, sometimes within 24 hours.

- 17. In all future correspondence with AIIMS, Kalyani registered vendors are required to quote the Registration No. and Category code
- 18. The AIIMS, Kalyani has all the rights to add/delete/alter any of the items and to amend/add any of the terms and conditions included in the registration granted to firms with effect from any date, without assigning any reasons for the same.
- 19. The AIIMS, Kalyani has all the powers to blacklist a firm after giving reasonable opportunity for defense.
- 20. All the pages of the document being submitted would be required to be duly stamped & signed by the Vendor.

Removal of Firms from the list of Registered Vendors

In case of violation of terms and condition of the registration, the registration of the firm will be cancelled by giving prior notice. Registration of Vendor is liable to be cancelled from the list of approved Registered Vendors in the case of the followings:-

b) Any false declaration to the Institute.

c) Supplied goods of inferior quality /uninspected goods/fails to supply in stipulated time.

d) It renders services (including after sales services and maintenance services) of inferior quality to the contracted ones.

e) It fails to execute a contract or fails to execute it satisfactorily as per the Institute.

f) The required technical / Operational staff or equipment are no longer available with the firm or there is change in its production/service line affecting its performance adversely.

g) It is declared bankrupt or insolvent.

h) It fails to submit the required documents/information for review of registration, whenever required.

i) It adopts unethical business practices, not acceptable to the government

j) It fails to respond to tender enquiry for more than three consecutive occasions will render the registration null and void.

k) If any ground on which the opinion of the registering authority is not in public interest.

1) If the registered Vendor fails to maintain the equipment during the warranty period or fails to maintain or repair on payment basis within 5 year from the supply of order, the Vendor's registration shall be cancelled and the Vendor will not be registered by the Institute in future, if applicable.

In all other cases provisions of GFR will apply.

All disputes in this connection shall be settled in KALYANI (WEST BENGAL) jurisdiction only.

Indemnity

The selected vendor shall indemnify the AIIMS, KALYANI and user departments against all thirty party claims of infringement of patent, trademark/copyright or industrial design rights arising from the use of the supplied items and related services or any part thereof. AIIMS, KALYANI/user department stand indemnified from any claims that the vendor's manpower may opt to have towards the discharge of their duties in the fulfillment of the purchase orders.
