GENERAL CONDITIONS

1. All the posts carry usual allowances as admissible to Central Government Employees of similar status at Kalyani (West Bengal).

2. 6. Maximum Age-limit: -

Tutor: - Not exceeding 30 (Thirty) years as of the date of publishing this notification on the Institute website. **Senior Resident:** - Not exceeding 45 (Forty-Five) years as of the date of publishing this notification on the Institute website.

(i) Upper age limit shall be determined as of the date of publishing this notification on the Institute website.

(ii) No age relaxation would be available to SC/ST/OBC Candidates applying for unreserved vacancies.

7. Candidates applying under any of the reserved category posts, viz. OH will be considered subject to OH Certificate issued by the appropriate/ Competent Authority on the prescribed format. The community should be clearly and legibly mentioned in the Certificate.

8. Only such persons would be eligible for reservation under OH quota in service/posts who suffer from not less than 40% of physical disability. A person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in the prescribed format.

9. The candidates are to satisfy all eligibility criteria. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be canceled at any stage if it is found that their educational qualification or experience is not recognized by the Govt. of India.

10. The post of Tutor and Senior Resident will be governed by CCS (Temporary Service) Rules.

11. Qualifications and Experiences: Qualifications and experiences as prescribed may be relaxed in exceptional cases at the discretion of the Selection Committee with prior approval of the Competent Authority. **The experience will be counted up to the date of publishing this notification on the Institute website.**
