## What is Internal Complaint Committee (ICC)?

- ICC is a body constituted by the administration of AIIMS, Kalyani. It deals with sexual harassment of women at workplace.

## Who can approach ICC, AIIMS, Kalyani?

- Any woman employee (Permanent/Contractual/Ad hoc/Tenure –based)
- Any female student (Medical/Nursing/Bachelor's degree/Master's degree/Paramedical)

## How to approach ICC, AIIMS, Kalyani?

- Any of the internal members may be approached personally at their respective office during working hours.
- Any of the internal members may be contacted over phone at any hours in case of any untoward incident.
- Complaint may be lodged by E-mail to any / all internal members to their personal E-mail ID or to the official E-mail ID of ICC, AIIMS, Kalyani (icc@aiimskalyani.edu.in)
  This is to be followed by submission of written complaint with signature to any of the internal members.

## What types of incidents must be reported to ICC?

- Any sexually oriented verbal comment/messages sent through electronic media/inappropriate gesture/sending offensive messages/pictures/inappropriate physical contact/attempt to make such contact, during working hours and beyond.

## How ICC members deal with a complaint?

- ICC members deal any complaint keeping the identity of the complainant and accused absolutely confidential.
- ICC gives equal opportunity to the complainant and the accused to present their case/defend themselves as the case may be.
- ICC collects substantial evidence for or against both the parties by all possible mechanism and preserves this evidence for future referral.
- ICC takes unbiased decision in conjunction with the external member and conveys their recommendation to the administration.
