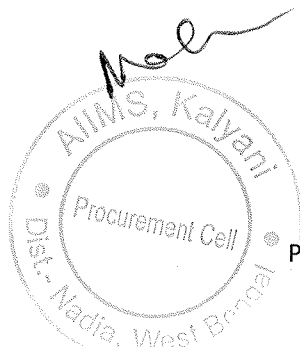

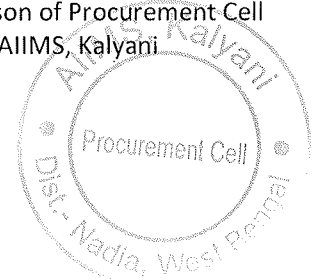



Technical Specifications for Ballistic and Ultrasound Lithotripsy Machine with inbuilt suction facility

- System should be intended for the fragmentation and removal of urinary tract calculi in the kidney, ureter, and bladder
- Should have Ballistic and Ultrasound energies through a single probe, simultaneously or separately to fragment stones
- Should have electromagnetically generated ballistic energy
- Should have inbuilt suction for extracting stone fragments through the probe while delivering energy or without delivering energy
- Should have a single foot pedal to operate both or one energy and suction
- Should have single hand piece for ballistic and ultrasound energies as well as suction
- Should have inbuilt active cooling mechanism for hand piece
- Should have facility for automatic recognition of probe by hand piece to configure the console parameters for each probe type, for automatic calibration of the energy level
- All probe and hand piece usage information should be automatically recorded in the console (number of uses, time of use, etc.)
- Should have large touch screen to select treatment modalities and to customize energy and suction settings
- Should display error code along with troubleshooting messages
- Should have facility to view the statistics for the last 5 treatment sessions
- Should have facility to export the statistics information on a USB drive
- Should have facility to collect the stone fragments for analysis
- Should have probes for various applications and scopes
- Should have quality meter for visual feedback about the efficiency of the treatment, by means of color bar
- Should have a HDMI connection to transfer the display information to an external monitor for surgeon to view the settings.
- Hand piece should be compatible for gas, glutaraldehyde sterilization or for autoclaving
