GENERAL CONDITIONS

- **1.** All the posts carry usual allowances as admissible to Central Government Employees of similar status at Kalyani (West Bengal).
- 2. The aspiring applicants satisfying the eligibility criteria in all respects can bring their application on the day of interview in prescribed format attached herewith along with self attested copies of certificates/documents in support of fulfilling the essential criteria of age, educational qualification, teaching/research experiences etc.
- 3. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria up to the date of publishing this notification in Institute website failing which their application will be rejected.

6. Maximum Age-limit: -

Senior Resident:- Not exceeding 45 (Forty Five) years as on the date of publishing this notification in Institute website.

- (1) Upper age limit shall be determined as on the date of publishing this notification in Institute website.
- (ii) No age relaxation would be available to SC/ST/OBC Candidates applying for unreserved vacancies.
- (iii) Age relaxation permissible to various categories is as under :-

Age relaxation to other categories of the candidates will also be applicable as per the DoPT instructions. However, age relaxation will be regulated as per the DoPT instructions.

7. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/OH/EWS will be considered subject to Caste/OH Certificate issued by the appropriate/ Competent Authority on the prescribed format as applicable. Community should be clearly and legibly mentioned in the Certificate.

OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s).

8. Only such persons would be eligible for reservation under OH quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format.

- **9.** The candidates are to satisfy all eligibility criteria. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is not recognized by the Govt. of India.
- **10.** The post of Senior Resident will be regulated as per the provision of Central Residency Scheme and governed by CCS (Temporary Service) Rules.
 - 11. All candidates are permitted to apply against posts earmarked for EWS subject to the following conditions:
 - a) That their candidature will be considered only if EWS applicants are not available.
 - b) That their candidature will be as UR candidates only, which means, there shall be no relaxations which are otherwise permitted under their specific categories.
 - c) Under no circumstance, the fees will be refunded.
- 12. Qualifications and Experiences: Qualifications and experiences as prescribed may be relaxed in exceptional cases at the discretion of the Selection Committee with prior approval of the Competent Authority. The experience will be counted up to the date of publishing this notification in Institute website.
- 13. Mode of Selection:- Based on the reporting, the Interview will be conducted after verifying the application and requisite documents of the candidates. The selection of the candidates will be based on the performance in the interview only. If candidates are not found eligible from advertised category, then candidates from other categories may be considered (against the concerned category on temporary basis) for interview.
