- 2. Pre-Qualification criteria

Intending Bidder would be eligible to submit the bid provided he complies with the following conditions:

- a. He should have satisfactorily completed similar works in *last 07 (Seven) Years* ending 31st Mar 2024 as follows:
- "for this tender similar work" means Building works (Civil or Electrical). The experience of similar work should be from Central Govt./State Govt./Centre PSU/State PSU and Autonomous Body
 - Three (03) similar works each of value **not less than 40%** of estimated cost put to tender

- 15. The contractor shall not be permitted to bid for works in AIIMS, Kalyani if his near relative is posted as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). No Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India will be allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of India in writing.
