1. The time allowed for carrying out the work will be 12 (Twelve) months from the Date of Start (which shall be reckoned from 10th day of issue of letter of acceptance).

2. Pre-Qualification criteria

Intending Bidder would be eligible to submit the bid provided he complies with the following conditions:

a. He should have satisfactorily completed similar works in *last 07 (Seven) Years* ending 31st Mar 2024 as follows:

"for this tender similar work" means AMC/CMC for water/sewage/effluent treatment Plants. The experience of similar work should be from Central Govt./State Govt./Centre PSU/State PSU and Autonomous Body

Three (03) similar works each of value **not less than 40%** of estimated cost put to tender

Or

Two (02) similar works each of value **not less than 60%** of estimated cost put to tender

Or

One (01) similar work of value **not less than 80%** of estimated cost put to tender

Note: The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 07% per annum, calculated from the date of completion to the last date of submission of bid.

- 6. In case the contractor fails to deposit the PSD, it will be deducted from the amount of his first running bill after making allowance for already deposited EMD.
- 7. The security deposit can be forfeited or utilized for rectification etc by order of this Institute in the event of any breach or negligence or non-rectification of defects or non-observance of any condition of contractor. Performance Security will be released after completion of contractor's obligations (including Warranty/Guarantee period) under the contract.
- 8. Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances, which may influence or affect their bid. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidder shall be summarily rejected.
- 14. Canvassing whether directly or indirectly, in connection to bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable to rejection.
- 15. The contractor shall not be permitted to bid for works in AIIMS, Kalyani if his near relative is posted as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the AIIMS, Kalyani. Any breach of this condition by the contractor would render him liable to be disqualified from this tender and be removed from the approved list of contractors of this Department.
- 16. No Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India will be allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the bid or engagement in the contractor's service.

SCOPE OF WORK

<u>Name of the Work:</u> Annual Comprehensive Maintenance and Operation of (1200 KLD and 500 KLD) STP Plants and 100 KLD ETP plant at AIIMS, Kalyani.

A: Scope of work

- 1. This work is for operation (with labour and material) and maintenance (comprehensive) of STPs and ETP of AIIMS Kalyani in order to keep the effluent water quality parameters as per Govt/WBPCB directives and re-use of treated water for Horticulture, Cooling Tower and flushing work with zero discharge.
- 2. Under this work, there are 2 (Two) no. of Sewage Treatment Plants (1200KLD & 500KLD) and 01 (One) no. of ETP Plant 100KLD including all storage chambers, pump sets, air blowers, filtration system, spare and Electric Driven Pump Set etc.
- 3. Operation and maintenance of the STP & ETP plants include various pumps, motors, blowers, pipelines, septic tanks, filter unit, etc. together with the electrical panel and connections operators.
- 4. The contractor will also be responsible for Operating UF system and Softener system and to ensure uninterrupted water supply to residential building for flushing and irrigation, for hospital building for flushing and irrigation and for HVAC chiller plant.
- 5. In addition to plants maintenance, the contractor would also do maintenance of 3 lines (Flushing line, Irrigation line and Soft water outlet emanating from STP upto receiving end). This will include all spares, repairs in case of line damage or blockage or replacement of worn-out or damaged fittings etc.). However, underground lines are excluded from scope of this work.
- 6. It will be the responsibility of Contractor to remove excess sludge from sludge holding tank. In addition, the Contractor shall also carryout cleaning of Grease/Sludge holding Tanks periodically, and disposal of grease / sludge outside the premises on their own cost.
- 7. For operation of plant, the manufacturer's recommendations would have to be followed. If some changes or addition is required to meet the end objective, the same should also be implemented after consultation with AIIMS Kalyani.
- 8. Continuous monitoring of all regular parameters for treated waste water is to be done by the contractor
- 9. This being the first maintenance contract, the contractor has to make one time initial repairs, cleaning, seeding, calibrations etc. if any, required for making all units and components functional. Their quoted rate for one-year comprehensive maintenance would be inclusive of this one time initial repairs.
- 10. The contractor will also be checking the levels of Equalization tanks and arrange for pumping of the Sewage collected in the tanks at times / regularly, so that the waste water at no point of time overflows the tank and cause a health hazard to the occupants of the AIIMS, Kalyani surroundings.
- 11. The WBPCB has in their Consent to operate vide memo No: 06/25/CFE(BM)-4380/2020 dated 14/09/2020 prescribed the following limits for various parameters of the treated effluent:

The quality of sewage and trade effluent to be discharged from your factory shall satisfy the permissible limits as prescribed in IS:2490(Pt.1) of 1974, and/or its subsequent amendment and Environment(Protection)Rules 1986.
