Important Note: -

- 1. The aforementioned provisionally eligible candidates are required to appear for **OMR Based Screening** Examination, comprising 50 Multiple Choice Questions (MCQ) covering three subjects i.e. Nursing Education, Nursing Management and Nursing Research.
- 2. The screening examination is scheduled to be conducted on **02.07.2025** and result of the said examination will be declared on the same day. Based on the performance in the screening test, candidates will be shortlisted for the Personal Interview to be held on same day i.e. on 02.07.2025. However, the number of candidates to be shortlisted shall be determined by the Competent Authority.
- 3. This notification shall be treated as an **intimation** to all provisionally eligible candidates. However, separate call letter/admit card will be sent to all the provisionally eligible candidates for appearing screening test.
- 4. The candidature of all provisionally eligible candidates is purely provisional and subject to subsequent verification and fulfillment of the prescribed eligibility conditions, including age, essential qualifications, experience, and reservation norms. If any candidate is found ineligible at any stage, their candidature shall be summarily cancelled. Mere appearance in the screening test/interview shall not confer any right for selection.
- 5. All candidates are required to **report with original documents** for verification, along with one set of **self-attested photocopies** of all relevant documents in support of their eligibility (qualifications, experience, etc.), as per the advertisement. Failure to produce the same shall lead to disqualification from the screening/interview process.
- 6. Candidates who are presently serving in Government service, including employees of AIIMS, are mandatorily required to produce **No Objection Certificate (NOC)** from their employer at the time of interview. No candidate shall be allowed to appear for the interview without submission of a valid NOC, as per the conditions stipulated on the advertisement.

- 7. The aforementioned list of provisionally eligible candidates is tentative and subject to change (both inclusion and exclusion) upon detailed scrutiny and verification. The decision of the Competent Authority shall be final and binding in this regard.
- 8. Candidates are advised to **strictly comply with the remarks** (if any) mentioned against their names by bringing the requisite documents during the document verification on the **date of Personal Interview** at the institute.
- 9. If the interview is not completed in the stipulated day and time, the candidate may have to attend the same on subsequent day.
- 10. No TA/DA shall be provided for this purpose
