The eligibility list for the same was published on the AIIMS Kalyani website on 28.06.2025 (Adv. no 1437/E-12015/ 19/25-(SR/T/JR), dated 28.06.2025).

All eligible candidates are required to submit a **Demand Draft of ₹1000/- (Rupees One Thousand only)** to appear for the interview.

The details of application Fees:

APPLICATION FEES: Rs. 1,000/- (Rupees One Thousand Only).

1) For Unreserved/OBC/EWS candidates of both sexes is Rs.1000/-.

The candidates have to pay the prescribed application fee through Demand Draft in favour of "AIIMS KALYANI INTERNAL RESOURCES ACCOUNT" payable at Kalyani.

2) Application fee once remitted shall not be refunded under any circumstances.

3) No fees for SC/ST candidates

4) Applications without the prescribed fee will not be considered and summarily rejected.

Candidates must bring the original Demand Draft on the day of the interview. No candidate will be allowed to appear for the interview without submission of the requisite fee.
