4.4. The agencies/firms/contractors for execution of similar works include major /minor repairs/addition /alteration / extension for services in categories as mentioned in the registration documents seeking application form shall have to pay the requisite (cost/fee)amount as stated below, for registration / enlistment.

7. General Conditions

- II. AIIMS, K reserves the rights to accept, consider or reject any or all applications without assigning any reasons thereof. The decision of AIIMS, K in respect of registration of parties for various categories of work / items will be intimated by post /email and shall be final & binding on all concerned registered firms / vendors in the panel of AIIMS KALYANI.
- III. Vendors once empaneled, shall have to promptly reply to all the enquiries, execute orders as per the order terms of AIIMS, K and keep the Institute informed of new products/ developments / innovative ideas that shall help reduce the cost and improve quality, reliability, etc.
- IV. This document is treated as a valid contract between AIIMS KALYANI and Vendor and adherence to all aspects of fair trade practices in executing the purchase orders / work orders placed by AIIMS KALYANI from time to time during the registration period.
- V. - i. - ii. If the vendor, in either of the above circumstances, does not take remedial steps within a period of 15 days after receipt of the default notice from AIIMS KALYANI (or takes longer period in-spite of what AIIMS KALYANI may authorize in writing), AIIMS KALYANI may terminate the enlistment/ Work Order in whole or in part.
